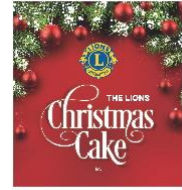

Did you know? Businesses and 'Not-for-Profit' organisations can order Lions Christmas Cakes on-line at www.lionschristmascakes.org.nz and **your Lions Club** can reap the benefit – easy, HERE'S HOW!

The 'business/not-for-profit' order form on our Lions Clubs' Christmas Cake website calls for the nomination of a Lions Club to be the beneficiary of income arising from any on-line purchase of Lions Christmas Cakes - it could well be your club. **No further action is necessary from your Lions Club**. Just sit back and receive your profit share when in January we close off the Christmas Cake season.
